### STATE OF TEXAS V. JA

- ▶ *Possession of Marijuana < 2oz*
- ▶ *Reduced to Class C misdemeanor, no drivers license suspension*
- ▶ *02/11/2015*

### STATE OF TEXAS V. RW

- ▶ *Felony DWI 3rd or More*
- ▶ *Result: Reduced to Class B misdemeanor, probation*
- ▶ *02/13/2015*

### STATE OF TEXAS V. JK

- ▶ *Theft \$50-\$500 and Driving While License Invalid*
- ▶ *Result: Reduced to Class C theft and DWLI was time served*
- ▶ *04/08/2015*

### STATE OF TEXAS V. TR

- ▶ *DWI*
- ▶ *Result: Reduced to Obstruction of Highway Passageway*
- ▶ *04/21/2015*

### STATE OF TEXAS V. FW

- ▶ *Possession of Marijuana < 2oz*
- ▶ *Result: Dismissed*
- ▶ *04/29/2015*

### STATE OF TEXAS V. JI

- ▶ *Duty on Striking Unattended vehicle. Client was undocumented immigrant and struck several parks cars, a conviction of which could result in possible immigration consequences*
- ▶ *Result: Dismissed, thereby avoiding immigration consequences*
- ▶ *05/06/2015*

### STATE OF TEXAS V. CS

- ▶ *DWI with open alcohol container. Client was facing a CDL license suspension so he decided to go to trial.*
- ▶ *Result: Reduced to Obstruction of Highway or Passageway prior to trial, no further implications on CDL license*
- ▶ *06/09/2015*

### STATE OF TEXAS V. SB

- ▶ *DWI. Blood was drawn over three hours after the stop. Set the case for trial.*
- ▶ *Result: Reduced to Obstruction, time served prior to trial*

### STATE OF TEXAS V. IG-R

- ▶ *Tampering with Government Record. Client was undocumented immigrant who allegedly possessed a fake ID, a conviction of which could result in possible immigration consequences*
- ▶ *Result: Reduced to Class C No Driver's License, thereby avoiding immigration consequences*
- ▶ *06/23/2015*

### STATE OF TEXAS V. CR

- ▶ *Theft \$50-\$500. Client was a student in school who allegedly stole cell phones from gym bags during PE and pawned them at resale kiosks*
- ▶ *Result: Dismissed*
- ▶ *07/14/2015*

### STATE OF TEXAS V. LS

- ▶ *Unlawful Use of Motor Vehicle. Client allegedly driving a stolen vehicle with fake plates.*
- ▶ *Result: Dismissed*
- ▶ *11/13/2015*

### STATE OF TEXAS V. HD

- ▶ *DWI 2nd. Client stopped for failing to maintain single lane. Blood draw resulted in .06 alcohol concentration and additional drugs in system; motion to suppress was filed prior to trial*
- ▶ *Result: Reduced to Obstruction of Highway or Passageway after “advisory opinion” on Motion to Suppress*
- ▶ *11/30/2015*

### STATE OF TEXAS V. KC

- ▶ *Probation Revocation on Felony Theft.*
- ▶ *Result: Revocation withdrawn with payment of restitution*
- ▶ *12/01/2015*

### STATE OF TEXAS V. AS

- ▶ *Evading Arrest in a Vehicle (2nd degree felony due to prior pen trip)*
- ▶ *Result: Reduced to a Class C ticket for Reckless Driving*
- ▶ *12/16/2015*

### STATE OF TEXAS V. AS

- ▶ *Accident Involving Damage*
- ▶ *Result: Prosecution Barred pursuant to Tex. CCP 12.45*
- ▶ *12/23/2015*

### STATE OF TEXAS V. WB

- ▶ *DWI BAC >.15. Client allegedly crashed in to gas station; .344 blood alcohol concentration; jury did not believe State could prove client operated the motor vehicle*
- ▶ *Result: Acquittal*
- ▶ *07/18/2016*

### STATE OF TEXAS V. CB

- ▶ *Probation Revocation for Felony Theft of Property*
- ▶ *Result: Motion to Revoke Withdrawn*
- ▶ *12/08/2016*

### STATE OF TEXAS V. MA

- ▶ *Theft by Check*
- ▶ *Result: Dismissed*
- ▶ *01/27/2017*

### STATE OF TEXAS V. AB

- ▶ *Assault Family Violence. Victim calls 911 to report that her husband allegedly assaulted her with a leather belt and remote control.*
- ▶ *Result: Acquittal*
- ▶ *Date: 03/06/2017*

### STATE OF TEXAS V. MP

- ▶ *Assault Family Violence*
- ▶ *Result: Dismissed*
- ▶ *04/03/2017*

## STATE OF TEXAS V. DP

- ▶ *Assault Family Violence*
- ▶ *Result: Dismissed*
- ▶ *06/12/2017*

## STATE OF TEXAS V. SR

- ▶ *Violation of Protective Order*
- ▶ *Result: Dismissed prior to trial*
- ▶ *06/19/2017*

## STATE OF TEXAS V. DD

- ▶ *DWI 3rd or More. Client was a convicted felon, facing minimum 2 years up to 20 years if convicted of DWI. Plea bargain offered by DA was 12 years prison.*
- ▶ *Result: Guilty verdict from jury but upon recommendation from jury to Judge for rehabilitation, Judge granted client probation with 90 days SAFP*
- ▶ *04/28/2017*

## STATE OF TEXAS V. JG

- ▶ *Assault Family Violence. A 911 caller stated that my client was punching a female passenger while driving. The caller testified at trial that my client also shoved the victim's face against the car window several times and that he dragged her out of the car.*
- ▶ *Result: Acquittal*
- ▶ *06/14/2017*

## STATE OF TEXAS V. CR

- ▶ *Deadly Conduct*
- ▶ *Result: Dismissed*
- ▶ *07/11/2017*

## STATE OF TEXAS V. MM

- ▶ *Possession of a Controlled Substance PG 3<28G*
- ▶ *Result: Dismissed*
- ▶ *07/20/2017*

## STATE OF TEXAS V. CS

- ▶ *3 counts of Sexual Assault of a Child*
- ▶ *Result: Acquittal*
- ▶ *12/06/2018*

## STATE OF TEXAS V. RW

- ▶ *Felony Driving While Intoxicated*
- ▶ *Result: Reduced to Class B misdemeanor, probation granted*
- ▶ *01/09/2019*

## STATE OF TEXAS V. DS

- ▶ *Assault of Public Servant*
- ▶ *Result: Dismissed after indictment*
- ▶ *02/20/2019*

## STATE OF TEXAS V. TM

- ▶ *Unlawful Possession of Firearm in Prohibited Place. Client showed up to airport with a handgun in his carry on backpack.*
- ▶ *Result: Jury returned No Bill after reviewing grand jury packet submitted by defense*
- ▶ *04/01/2019*

## STATE OF TEXAS V. PM

- ▶ *Felony Driving While Intoxicated 3rd or More*
- ▶ *Result: Reduced to Class A misdemeanor*
- ▶ *05/08/2019*

## STATE OF TEXAS V. EA

- ▶ *Assault Family Violence*
- ▶ *Result: **Acquittal***
- ▶ *06/27/2019*

## STATE OF TEXAS V. AR

- ▶ *Driving While Intoxicated. Client arrested for DWI and had DACA status. Set the case for trial.*
- ▶ *Result: Dismissed prior to trial*
- ▶ *12/09/2019*

## STATE OF TEXAS V. SP

- ▶ *Possession of Controlled Substance enhanced to second degree felony due to multiple pen trips*
- ▶ *Result: Probation granted despite multiple negotiations with trial prosecutor resulted in pen time only offers*
- ▶ *01/07/2020*

## STATE OF TEXAS V. CS

- ▶ *Motion to Adjudicate Guilt filed based on two new offenses and multiple dirty drug tests*
- ▶ *Result: Probation Violation Withdrawn and Client extended on probation for additional year*
- ▶ *01/09/2020*

## STATE OF TEXAS V. RR

- ▶ *Continuous Assault Family Violence*
- ▶ *Result: Reduced to Class A misdemeanor, time served*
- ▶ *01/10/2020*

## STATE OF TEXAS V. NF

- ▶ *Two indictment for Aggravated Assault with a Deadly Weapon Family Violence. Client was arrested for pointing a gun at the mother of his baby while she slept, and then grabbing the baby by his neck, putting the gun to the baby's temple and threatening to kill the baby. Client was facing a minimum of 25 years to life in prison. The District Attorney offered him 12 years in exchange for a plea of guilty. Client demanded a trial.*
- ▶ *Result: Mistrial declared on both cases after nearly two full days of jury deliberation.*
